PLAN OF THE LOTTERY.

The numbers from 1 to 50,000, corresponding with the numbers on the tickets, printed on separate slips of paper, are rolled up and encircled with small brass tubes, and placed in a Glass Wheel. The amounts of the different 200 full Prizes, similarly printed and encircled, are placed in another wheel. The number and the prize drawn out are opened and exhibited to the audience, and registered by the Commissioners, the prize being placed against the number drawn. This operation is repeated until all the prizes are drawn out.

The \$500 prizes of \$20 each, are determined by the last figure of the number which draws the highest Capital Prize, (\$40,000.) For example:—If the number drawing the \$40,000 prize ends with figure 1, then those \$500 tickets having numbers ending in figure 1 will be entitled to \$20. If the number ends with figure 2, then those tickets where the number ends in figure 2 will be entitled to \$20, and so on to figure 0.

PACKAGES TEN DOLLARS.

Prizes payable in full without deduction.
